

# Nebraska Pork Producers Association Voluntary Herd Plan Rebate Program Form

The Nebraska Pork Producers Association is Offering \$100 Rebates to Producers Completing a Herd Plan prior to a PEDv outbreak or positive test after October 15, 2014 up until December 31, 2015.

The NPPA Board of Directors have earmarked \$10,000 to reimburse Nebraska producers who voluntarily initiate a herd plan with their veterinarian prior to a Porcine Epidemic Diarrhea virus (PEDv) outbreak or positive test. Five thousand dollars is immediately available and an additional five thousand dollars will be awarded in 2015. The purpose of this program is to encourage producers to be proactive by establishing a herd plan prior to a PEDv outbreak or positive test. A herd plan will assist the producer's biosecurity plans for PEDv and will be of major importance in the case of any future foreign virus or disease outbreak. This pro-active approach is a commitment to combating PEDv, any other foreign virus and protecting the pork industry in Nebraska. ## The following requirements & stipulations apply:

- Producer must have Herd Plan completed by Veterinarian.
- Producer must have a copy of completed Herd Plan on site & filed with their Veterinarian.
- Rebate form must postmarked on or before October 15, 2014 through December 31, 2015.
- Limit of one rebate per premise ID registered as a "reproductive unit".
- Rebates will be processed in a timely manner.
- Rebate amount will equal \$100.
- **Rebates available on a first-come, first serve basis, as long as funds are available.**
